DIRECTION NO. 3**

**PERMANENT IMPAIRMENT ITEM NUMBERS**

This is a corresponding provisions and pending matters direction made in accordance with section 548 of the *Workers Compensation and Injury Management Act 2023* (2023 Act).

This direction sets out the item numbers in Schedule 2 Part 2 of the *Workers' Compensation and Injury Management Act 1981* (1981 Act) that correspond with the item numbers in the Table under section 101 of the 2023 Act.

The direction may be relevant to an assessment under a provision of the 1981 Act by an approved medical specialist of a worker's degree of permanent impairment that is taken to be an assessment under the corresponding provision of the 2023 Act by an approved permanent impairment assessor of the worker's degree of permanent impairment (see section 581 and Corresponding Provisions and Pending Matters Direction No.2).

This direction is effective 1 July 2024.

**Corresponding provisions direction [s. 548(1)(a)]**
